

Your conveyancer receives a compliant and secure, quality assured report confirming your identity check. This report is not used for any other purpose.



#### **Acceptable Identity Documents**

You will need to be able to provide documents within one of the following categories. You will be asked to nominate these at the time of booking.

Documents must be original (no photocopies) and must not have expired.

If your identity documents are not exactly the same as the name shown on the title to the property, please contact your Conveyancer before booking. Where you have been married or changed your name, you may need to provide a Marriage Certificate or Change of Name Certificate to link the names across your documents.
